We, at Sakthi Veera Green Energy Private Limited (We, Us, Our, Veera, Company) and our affiliates take data privacy seriously and are committed to protecting it. It is, therefore, critical that we brief you about how Veera collects, processes, uses, and discloses information while running its business.

### **1.Scope**

This page informs you of our policies regarding the collection, use and disclosure of Personal Information we receive from users of the Site. This Policy covers only data collected through the Site/s (our homepage <https://veeragroup.net> and sub domains, and related mobile applications, if any) and does not cover any other data collection or processing, without limitation, collection conducted offline, or through our products or services that do not link directly with this Policy, or by third-party sites that we may link to. We use your Personal Information only for providing and improving the Site. By using the Site, you agree to the collection and use of information in accordance with this policy. ### **2.Collection and Use of the Data**

While using our Site, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you. Personally identifiable information may include, but is not limited to your name (“Personal Information”).

We may collect information that your browser sends whenever you visit our Site to browse, place order for products or to pay for purchase of our products. This Data may include information such as your computer’s Internet Protocol (“IP”) address, browser type, browser version, the pages of our Site that you visit, the time and date of your visit, the time spent on those pages and other statistics. Any communication which, in its sole discretion, the site deems to be a testimonial, may be publicized for commercial purposes.

“Cookies” is web jargon for bits of computer code placed on your hard drive. ### **3.Spam**
